<p>Youth Business Programs: YouthBiz, Inc. provides after-school and summer programs for at risk youth, which develop business, academic and leadership skills through peer-to-peer learning and hands-on training. Program success is measured through quantitative and qualitative evaluations throughout the year, which include: pre and post tests, data collection from schools, individual success plans, focus groups and personal interviews. In 2007, a total of 327 youth were served and over \$150,000 in incentives and wages was paid directly to youth trainees and leaders. In addition, 160 desktop computers were refurbished and distributed. On average, participants received 140 personal contact hours per session. The positive academic and behavioral changes among youth served included: 80% increase in grade point average, 58% increase in school attendance, 75% decrease in referrals, 70% decrease in suspensions, and 100% grade advancement. The entry-level program, Tier I: YouthBiz - Basics, focused on workforce development and transferable like skills. Tier I trainees completed training in the following areas: computer hardware and software applications, career exploration, interviewing/applying for jobs, basic business skills, interpersonal communication, public speaking, and leadership development. The advanced program, Tier II: YouthBiz - Advanced, focused on entrepreneurial development. Tier II youth completed hands-on activities related to financial literacy, business planning, advertising/marketing, human resources, and service learning. Participants applied their newly acquired business skills in a real-life setting through our in-house screen-printing business, YouthInk. Tier II youth also completed job shadows in a field of interest and a group and individual community-service project. Story 1: Anna came to YouthBiz unsure about herself and her future. As a trainee, Anna accomplished each task with ease and acquired skills and discipline that applied to both her job and her school work. Through public speaking training, Anna's confidence grew strong in a short amount of time. Eventually, Anna became a crew leader and supervisor. Anna shared, "my whole life would be different if I hadn't filled-out a YouthBiz application." A girl who once believed she would never attend college, Anna graduated a year early from South High School in May 2007 with a 3.7 GPA. At sixteen, she became a freshman at the Community College of Denver in the fall of 2007. Anna is interested in becoming a teacher. Story 2: From the time she was a young girl, Jessica loved basketball, music, and art. With a tough exterior and a soft heart, Jessica became a key figure at YouthBiz, working as a Production Intern with YouthInk. In this role, she learned invaluable business skills from production to customer-service, and has shared these skills with her peers. What Jessica likes most about YouthBiz is that "many of the staff members are youth who learn and teach as they go." Jessica was once an extremely shy girl with little self-esteem, now she is a confident and bold leader.
